# **<u>1. EXECUTIVE SUMMARY</u>**

# **1.1 INTRODUCTION**

"Education is not the amount of information that is put into your brain and runs riot there, undigested, all your life. We must have life-building, man-making, character-making assimilation of ideas."

Located at the tribal heartland of *Jungle Mahal* (forest region), Seva Bharati Mahavidyalaya is one of the premier higher educational institutes in the newly-formed district of Jhargram in West Bengal with its glorious educational history and heritage of six decades. Established on 17th July 1964 by the renowned Agricultural Scientist, Professor Pabitra Kumar Sen (1906-1997), the college has evolved into a large multidisciplinary higher education institute that aims at empowering the underprivileged section of the society by imparting quality education to the rural people, particularly the women, poor, tribal and backward classes. Within the framework of university-prescribed curricula, the potentiality for increasing human resources within the locality is encouraged through the Upanishadic teachings and ideals of Rabindranath Tagore, Swami Vivekananda, Mahatma Gandhi and other contemporary thinkers of India. Recognized under Sections 2(F) and 12(B) of UGC Act, the college was formerly affiliated to the University of Calcutta and since 1st June 1985 the college has been affiliated to Vidyasagar University, Paschim Medinipur, West Bengal.

Seva Bharati Mahavidyalaya is a co-educational institution which functions in two shifts, morning and day, accommodating a huge number of students from the periphery of Jhargram district. The college offers 11 UG Honours Courses, B.A., B.Sc. General Courses and Bachelor in Physical Education (B.P.Ed.). Students with varying learning abilities are enrolled and courses are offered to the marginalized sections of young students and the first-generation learners from the Santal community. The permanent teaching faculty strength of 70 with the Principal has contributed to a vibrant academic atmosphere. Eleven (11) permanent and 19 contractual non-teaching staff are the backbone of our college.

Through imparting quality education to the young learners and empowering the students' community belonging to different economic, cultural, religious, ethnic, and linguistic backgrounds, this multidisciplinary college aims at contributing to the sustainable socioeconomic growth of the adjoining underdeveloped territory, which would subsequently contribute to the sustainable growth of the nation.

# **1.3 CRITERIA WISE SUMMARY**

#### **Curricular Aspects**

#### **Curricular Aspects**

The curriculum delivery of Seva Bharati Mahavidyalaya is a well-planned and documented process. As the college is affiliated to Vidyasagar University, it follows the regulations, guidelines and curriculum adopted by the University. The University implemented the Choice Based Credit System (CBCS) from the 2017-18 academic session and the college follows CBCS in the semester system as per the guidelines and regulations of the affiliating University. To ensure the smooth conduct of the teaching, learning and evaluation process of the college, the Academic Council and the Admission Committee with the Principal as the Chairperson conduct meetings before the commencement of each academic session and the decisions are conveyed to the respective departments for successful implementation. The Academic Council prepares the Academic Calendar and the Routine Committee prepares the Central Routine in compliance with the academic schedule of the University and is displayed on the college notice board and the college website. Before the commencement of classes in each academic session, the departmental teachers hold meetings, and as per the decisions taken in the Departmental Committee, they prepare meticulous Teaching Plans/Lesson Plans, chalk out the departmental activities which are conveyed to the students through the Departmental Notice Board. Along with the

traditional methods of teaching, the teachers employ problem-solving methods, organize quizzes, use ICTbased methods to make the learning experience learner-centric and participative. The college follows a curriculum in which different UG programs incorporate the topics of their respective courses that cover crosscutting issues like Gender, Human Values and Professional Ethics, Environment and Sustainability. In addition to the prescribed syllabus, several Certificate/Value-Added Courses are introduced from 2021-22 academic session for enhancing the skills of the students. In the last three years more than 20 Certificate/ Value-Added Courses have been offered to the students. The college obtains feedback on the academic performance from the various stakeholders at the end of each academic session and action is taken based on such feedback. Throughout the academic session, the Academic Committee, Examination Committee, Routine Committee and IQAC work in a coordinated manner to ensure smooth and effective curriculum delivery.

#### **Teaching-learning and Evaluation**

#### **Teaching-learning and Evaluation**

Seva Bharati Mahavidyalaya offers degree programs in Arts, Science and Commerce streams and it also offers degree in Bachelor in Physical Education (B.P.Ed.) course. The college follows the guidelines of the Government of West Bengal and the affiliating University regarding the admission process. With an objective to maximize transparency, the entire admission process of the college is conducted online. The college strictly adheres to the Government Reservation Policies at the time of admissions and ensures the fair representation of students from all communities. However, the demography of the area shows that there is a predominant population of minorities, Scheduled Tribes (ST) and Other Backward Castes (OBC). The college organizes Induction Programme for the students at the beginning of each academic session. The college has always focused on recruitment of qualified and competent fulltime teachers to ensure effective teaching-learning process. The student-teacher ratio in the latest completed academic year (2022-23) is 24:1. Percentage of fulltime teachers against sanctioned posts during the last five years is 78.95%. The teachers are qualified and competent and the percentage of fulltime teachers with NET/SET/M.Phil./Ph.D. during the last five years is 65.71%. Teachers are encouraged to pursue M.Phil./Ph.D. degrees and at present 10 teachers are pursuing Ph.D. The college conducts Internal Assessments of the students to assess student performance as per the guidelines of the affiliating University. Tutorial classes are held for the slow learners and additional study materials are provided for advanced learners. POs and COs of all the programs offered by the college are displayed on the website. Mentoring system has been introduced from the current academic session (2023-24). Students of the college display remarkable success in the University Examinations. Overall pass percentage of students is impressive with 94.9% in the last academic session (2022-23) in all streams with a significant percentage of first classes. The college is committed to provide an inclusive and conductive environment for all students aiming to pursue higher education.

#### **Research, Innovations and Extension**

#### **Research, Innovations and Extension**

Seva Bharati Mahavidyalaya has created an ecosystem for innovation and knowledge creation by emphasizing academic and research activities. The college has formed a Research and Project Work Sub-Committee that encourages teachers to publish original research papers in reputed journals. Presently 10 teachers are pursuing Ph.D. degree from various universities and a significant percentage of teachers contribute regularly to UGC-recognized journals and contribute chapters in books published by the national and international publishers. The

Conference, Seminar and Workshop Sub-Committee of the college not only takes an active role in organizing seminar/ webinars/ workshops, etc., it also inspires the teachers to present original research papers in various conferences/ seminars/ webinars/ workshops/ symposiums etc. The college had organized several national level and international level seminars/webinars in the last five years. The Central Library of the college has a large collection of books and journals.

The NSS Units of Seva Bharati Mahavidyalaya, under the supervision of the Extension Work Sub-Committee, organize a number of extension and outreach programs in the surrounding communities and seek to address the social, environmental and health issues of the local communities, inculcate social values and responsibilities among the stakeholders.

The college has created more than 25 functional MoUs/Linkages/Collaborations with academic institutions/ Govt. organizations/ private organizations in India for internship, on-the-job training, project work, student/faculty exchange and collaborative research works during the last five years.

### Infrastructure and Learning Resources

### **Infrastructure and Learning Resources**

Adequate infrastructural facilities are provided by the college which ensures effective teaching-learning and extra-curricular activities. The college is spread over 11.4 acres of land, with a built-up area of 9712.46 sq. mts. The college has four major buildings which accommodate office, classrooms, seminar halls, laboratories, library, and other support services and different Cells. The college also provides other facilities like hostels, canteen, drinking water, toilets, gymnasium, students' common room (girls'), cycle stand, and Yoga Center. The college has adequate sports infrastructure with 1 football/cricket playground, 1 basketball ground, 1 Kho-Kho ground, 4 volleyball courts, a fully-furnished indoor-games hall. The four hostels of the college are equipped with facilities for indoor games and recreational activities. Students are encouraged to participate in various cultural and literary activities like E/Wall magazine publications, Freshers' Welcome Ceremony, Teachers' Day celebration, Rabindra Jayanti, Basant Utsav, Annual Sports, etc.

The college has an adequate library infrastructure with a spacious Central Library (Approximately 1600 sq. ft.) and a spacious Reading Room (Approximately 1600 sq. ft.) which accommodate approximately 10000 printed books and journals. The Central Library of the college has been automated with ERP ILMS software from the 2022-23 academic session. The college has campus networking with LAN and Wi-Fi extending internet connectivity throughout the campus with a bandwidth of 100 MBPS. The college has one green generator. The college campus is under CCTV surveillance.

### **Student Support and Progression**

### **Student Support and Progression**

Seva Bharati Mahavidyalaya has effective mechanisms like Career Counseling and Placement Cell, Psychological Counseling Cell, Grievance Redressal Cell and several welfare measures for 'student support'. The college has successfully adopted several schemes, policies and procedures to provide students with scholarships and freeships, concession/exemption of tuition fees, etc. Various programs on soft skills, language and communication skills, life skills are organized to facilitate capacity development and skill enhancement of the students. The Career Counseling and Placement Cell of the college takes an active role in organizing training programs to prepare the students for competitive examinations and to enhance the opportunities of the students for success in the modern job market. The Grievance Redressal Cell handles grievances of the students with utmost urgency. The college takes every necessary precaution to ensure the safety and dignity of the stakeholders and to create a healthy and welcoming atmosphere where all can flourish without fear and prejudice. In this regard we must acknowledge that no cases of ragging or sexual harassment are reported during the assessment period.

Seva Bharati Mahavidyalaya has an excellent infrastructure for sports. The college has a strong Physical Education Department and the students of this department participate in various events and competitions at university/ state/ national level throughout the year. We encourage the students to explore their talents in sports and cultural activities which may contribute to the overall development of our students and foster a vibrant campus culture.

The college has a registered alumni association. The alumni are active and contribute significantly to the development of the college. The alumni participated in Cultural Festival, Plantation Programme, Covid-19 awareness camp, Sports Meet, etc.

By prioritizing student welfare, offering a comprehensive support system and fostering a culture of excellence, Seva Bharati Mahavidyalaya continues to mould the lives of the students by making significant positive impacts on their academic, personal and professional journeys.

#### **Governance, Leadership and Management**

#### Governance, Leadership and Management

The Governing Body of the college is the ultimate administrative authority for effective planning and implementation of academic and administrative policies. Keeping with the vision and mission of the college, the Governing Body frames policies and ensures their effective implementation with an objective for the sustained institutional growth. The Principal of the college acts as a great academic and administrative leader. The college promotes the culture of participative management. In order to ensure effective administration and efficient implementation of academic activities, the Governing Body of the college adopts the policy of decentralization of management through the formation of Academic Council, Finance Committee, Purchase Committee, Teachers' Council, IQAC, several Sub-committees and Cells comprising of teaching faculties, non-teaching staffs as members.

The college follows the service rules as defined by the Statutes of the affiliating University, Govt. of West Bengal and UGC. For professional development faculty members are encouraged to participate in different courses, workshops on CAS and research activities. The college has developed a mechanism of feedback collection from the faculty members for understanding their weakness and strength. There are several welfare schemes for the teaching and non-teaching staff of the college such as GPF Scheme, Puja Advance, etc.

Seva Bharati Mahavidyalaya has successfully implemented e-governance in the following areas of operation: Administration, Finance and Accounts, Student Admissions and Support. The college has evolved mechanisms for mobilization and optimal utilization of resources and funds from various government and non-government organizations and it conducts financial audits by the external/internal auditors to ensure continuous documentation and monitoring of financial transactions. The Internal Quality Assurance Cell (IQAC) in coordination with the different Sub-committees ensures effective planning and implementation of academic activities through regular meetings and reviewing of these activities. The key contributions of IQAC during the assessment period include: successful conduct of online teaching-learning during the pandemic, recruitment of a good number of qualified fulltime teachers, Academic Audit, Administrative Audit, Green Audit, Gender Audit, MoUs/Linkages/Collaborations with a number of government and non-government organizations, etc.

Seva Bharati Mahavidyalaya promotes equal opportunity for the students belonging to all the sections of the society, preaches gender equity, inclusiveness and strives for the development of basic human values. In order to address and identify the multiple forms of gender violence, weakness regarding gender balance, and to evaluate gender equity within the college, a Gender Audit was conducted by the IQAC and the Women Cell of the college. The college has active Internal Complaints Committee (ICC), Women Cell, Anti-ragging Cell, Grievance Redressal Cell to monitor gender equality within the institution.

The college aims at inculcating basic human values among its stakeholders and strives for maintaining a harmonious, inclusive environment within the campus. In order to make the stakeholders aware of their constitutional rights, duties and responsibilities, the college takes several initiatives to enhance the understanding and appreciation of cultural, regional, linguistic, communal and socio-economic diversities of the country. Several national and international commemorative days such as Independence Day, International Mother Language Day, International Women's Day, Santali Bhasa Vijoy Dibas, Republic Day, Birth Anniversary of Netaji Subhash Chandra Bose, etc. are observed and celebrated each year with fervour, devotion and dedication.

The college has an Environment Policy and adopted several environment-friendly initiatives to make the campus eco-friendly. Ours is a campus with no AC. The college conducted Green Audit/ Environment Audit, Energy Audit, and adopted clean and green campus initiatives, and beyond the campus environmental promotion activities. The college has taken some initiatives for energy conservation measures, management of the various types of degradable and non-degradable waste, water conservation, green campus initiatives, and disabled-friendly, barrier-free environment.

# Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:

In keeping with the vision of NEP2020, Seva Bharati Mahavidyalaya is quite prepared to transform itself into a holistic and multidisciplinary institute. The college offers undergraduate degree programs in 17

	disciplines that can be broadly categorized into Arts, Science and Commerce streams. The present curriculum of most of the subjects taught in the college contains the contents of multidisciplinary or interdisciplinary nature. Students of all programs in Arts, Science and Commerce learn modern Indian languages and conduct project works in Environmental Studies. Students are also encouraged to conduct research project works in the multidisciplinary/ interdisciplinary mode by selecting topics from different courses. Seminars/ conferences/ webinars on interdisciplinary topics are also organized by the departments. The college has academic collaborations with other higher educational institutes so that faculty and students can undertake programs on multidisciplinary or interdisciplinary subjects for the mutual benefit of the students and the institutes.
2. Academic bank of credits (ABC):	NEP2020 is implemented from the academic session 2023-24 with the introduction of 4 years UG degree programmes in the college. The flexibility in the curricular structure requires the establishment of Academic Bank of Credit (ABC). Since Seva Bharati Mahavidyalaya is affiliated to Vidyasagar University and follows the academic curricula designed by the affiliating university, the college has no scope for creation of ABC. It is the sole prerogative of the affiliating University.
3. Skill development:	Seva Bharati Mahavidyalaya aims at integration of education with skill development, a harmonious blending of theoretical knowledge with practical skills. For that purpose, the college organizes various programs, seminars and webinars, offers Value- Added Course/ Certificate Courses. The objective is not only to provide value-based education to inculcate positivity among the students that includes the development of humanistic, ethical, constitutional and universal human values but also to develop the skills of the students at various levels. The college offers BPED and B.A. General Course in Physical Education course which develop the sports and physical skills of the students. Seva Bharati Mahavidyalaya follows the university-prescribed curriculum that provides scope for skill enhancement through the Skill Enhancement Courses (SECs) which are designed to improve the cognitive, analytical, employable, communicative, and social

	skills of the learners. The college offers various Value-Added Courses/ Certificate Courses on soft skills and life skills which help the students to improve their skills and make them competent for job market.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	The Indian Knowledge Systems (IKS) encompasses a wealth of knowledge, practices and innovations accumulated over the ages which have their potentials to solve our contemporary socioeconomic, educational, environmental issues. Seva Bharati Mahavidyalaya follows the syllabus of Vidyasagar University which integrates these issues in its CBCS curriculum in a systematic and scientific pattern. The curriculum of the college includes the subjects like philosophy, history, literature, sports, mathematics, political science, science etc.; teaching of these subjects to the students makes the systematic delivery of Indian ancient knowledge feasible. The study of Bengali and Santali literature is helpful for the students for acquisition of knowledge in regional, tribal and indigenous cultures, while the study of Sanskrit literature makes the students aware of the Vedic ways of learning and cultural heritage. The harmonious blending of ancient knowledge system and the pragmatic values of the modern age is conducive for the holistic development of the students' personalities and the necessary acquisition of specialized skills. The college organizes various cultural programs/ events, and celebrates many festivals or commemorative days throughout the year which help the students to develop their sense of pride and knowledge of their own glorious cultural heritage. We follow the bilingual mode of teaching (English/Bengali) in all degree courses. We emphasize classroom education of all subjects in the vernacular languages i.e., Bengali and Santali to provide comprehensible, quality instructions to the students and to promote the strength, usage, and vibrancy of regional languages. Santali and Sanskrit are used as mediums of instruction in courses like B.A. in Santali and B.A. in Sanskrit courses respectively. The Bengali language is used mostly for communication with the students in classrooms. The department of Santali celebrates Santali Bhasa Vijoy Dibas every year. International Mother Language Day, Netaji Jayanti, Republic D

	Independence Day, etc. are organized every year in the college. The department of Bangali and Geography celebrate Basant Utsav. The college has established a Yoga and Meditation Center and offers Value-Added Courses/ Certificate Courses on Yoga and Meditation for promoting Indian knowledge System.
5. Focus on Outcome based education (OBE):	Implementation of outcome-based education has been one of the priorities of Seva Bharati Mahavidyalaya and several initiatives have been adopted for that purpose. On the instruction of IQAC, all the departments prepare detailed and meticulous document on Program Outcomes (POs), Program Specific Outcomes (PSOs) and Course Outcomes (COs). Program Outcomes (POs), Program Specific Outcomes (PSOs) and Course Outcomes (COs) prepared by the departments are published on the departmental web page of the college website. Teachers are also well oriented at the beginning of the academic session regarding these learning outcomes by the Academic Council and IQAC. The students are made aware about the outcomes and skills that they may acquire after the successful completion of the course. In the line and spirit of NEP2020, the college has shifted its focus on the popularization of outcome-based education and designed several Value-Added Courses and Certificate Courses for enhancing the scope of employability of the students.
6. Distance education/online education:	Along with the conventional modes of teaching, learning and evaluation, Seva Bharati Mahavidyalaya makes an effective use of digital or online medium for teaching and learning activities. The college has successfully accomplished the teaching, learning and evaluation through the online mode by using digital platforms like Google Meet, Zoom, WhatsApp, Telegram, YouTube, etc. during the COVID-19 pandemic. The college has actually gone for blended learning as many Value-Added Courses/ Certificate Courses are offered online in addition to the regular offline programs. The implementation of blended learning has become the top priority of the college in recent times. Along with the traditional classroom teaching, many departments still conduct Webinars/ Special Lectures/ Lecture Series/ evaluation, etc. in online mode. Seva Bharati Mahavidyalaya is the Study Centre of Netaji Subhas Open University

(NSOU) which offers several courses through the
distance mode. The students and teachers are
encouraged to use platforms such as SWAYAM, You
Tube content making, e-content making, Blogs, etc.
All teachers of the college are competent for
conducting teaching, learning, and evaluation in the
online mode and are capable of providing online
education to the students as may be required under
NEP2020.

# **1.1 Curricular Planning and Implementation**

# 1.1.1

The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

### **Response:**

Seva Bharati Mahavidyalaya is a government-aided college and affiliated to Vidyasagar University and hence follows the curriculum and the Academic Calendar prescribed by the affiliating university. The college ensures curriculum delivery effectively, strategically and ensures flexibility to the students in the following ways:

- At the beginning of each academic session, the Academic Council of the college, under the supervision of IQAC, prepares the Academic Calendar adhering to the Academic Calendar provided by Vidyasagar University. The Academic Calendar is uploaded on the college website and displayed on the college Notice Board.
- After the publication of the Academic Calendar by the Academic Council, the Routine Committee of the college prepares the Central Routine for the academic session which is distributed to the respective Heads of the Departments and is uploaded on the college website and displayed on the college Notice Board.
- The Heads of the Departments (HODs) conduct meetings with their departmental faculty members and prepare the departmental routines based on the Central Routine. Each faculty member is assigned a particular portion of the curriculum for teaching. Faculty members prepare Lesson Plans according to the assigned curriculum and the proceed to the implementation of curriculum within the given frame of time.
- The Principal, IQAC Coordinator, and the Academic Council conduct a meeting at the beginning of each academic session to chalk out the strategies for effective implementation of curriculum. The schedule for Internal Assessment, evaluation process, teaching-learning methods are also discussed in this meeting. The changes in the syllabus notified by the university and changes of regulations, if any, are discussed and noted.
- The faculty members mostly follow the traditional chalk and talk methods for curriculum delivery. A few departments have the facilities for ICT-enabled classrooms where the teachers follow the lecture methods along with modern teaching and learning methods.
- The teaching-learning process is supplemented with Seminars, Webinars, Special and Extension lectures, Projects, Group Discussions, Field Works and the preparation of e-Magazines or Wall Magazines.

- The Examination Committee prepares the schedule for Internal Assessment which is circulated among the students well in advance to ensure smooth conduction of examinations. Internal Assessments are arranged by the college as per the guidelines of the Vidyasagar University. The continuous evaluation process is emphasized in the process of curriculum delivery. Question papers are prepared and answer scripts are evaluated by the faculty members as per the decisions of the departmental committee. Online assessments are conducted whenever offline assessments are not possible due to pandemic situations.
- Tutorial classes are held for the weak learners. Extra care is taken for the advanced learners by providing them with additional study materials.
- The departments organize several cultural programmes, poster presentations, publications of e-Magazines or Wall Magazines for further development of academic and cultural performance.
- Several departments offer Value-Added Courses/ Certificate Courses on diverse topics adhering to the academic plan of activities.

### **Response:**

With the focus to enhance the learning experiences of students, Seva Bharati Mahavidyalaya adopts methods like experiential learning, participative learning and problem-solving methodologies both inside and outside the classroom. These methodologies help to transform students from passive recipients to active agents with the capacity for critical thinking. The teaching-learning process is thus designed in such a way as to ensure the students' active involvement in class activities.

### **Experiential Learning:**

- Experiential learning in the forms of field visits and project work has been incorporated into the university-prescribed syllabus for undergraduate programs in various subjects like Bengali, Geography, Botany, Anthropology, and Santali.
- Project Work on Environmental Studies has been made compulsory for all UG Semester-II students under CBCS system in Vidyasagar University.
- Department-specific activities like one day field trips, study tours, long excursions are also conducted by several departments.
- Laboratory demonstrations other than practical classes are conducted in some departments.

### **Participative Learning:**

In addition to experiential learning, participatory learning has also been incorporated into the teachinglearning process to make it more student-centric.

- Group discussions, quizzes, projects, poster presentations, etc. are organized by the departments which help the students to get actively involved in the teaching-learning process and these activities provide them the opportunities to explore their creative faculties and skills.
- The departments of Bengali, English and Geography publish Wall Magazines/ e-Magazines which provide the departmental students the opportunities to explore their creative faculties and critical thinking abilities, making the learning process lively, pleasurable and engrossing.
- Students actively participate in various co-curricular activities and outreach activities organized by NSS, various Committees and Cells, and departments.
- The students of the college participate and organize various cultural programs and events like Freshers' Welcome, Teachers' Day, etc.
- The students of the college, particularly the students of Physical Education, participate in various University-level, State-level and National-level competitions and events.

The entire learner-centric teaching-learning and evaluation process is enriched with the effective use of ICTs. Since COVID-19 pandemic, teachers and students have been extensively using different virtual platforms like Google Meet, Zoom, etc. for teaching-learning purposes. Seminars, Webinars, Extension Lectures, Special Lectures are organized offline/ online by the departments in which students actively participate. WhatsApp groups, official Facebook page of the college and email are used as platforms to communicate, make announcements, circulate notifications, address queries and share information. Several departments have the ICT-enabled classroom facilities.

# **2.5 Evaluation Process and Reforms**

#### 2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

#### **Response:**

- Seva Bharati Mahavidyalaya is affiliated to Vidyasagar University and is guided by the affiliating university in all the matters related to syllabi, examination and evaluation. The college has a powerful mechanism that ensures the evaluation process in a transparent and efficient manner.
- The CBCS pattern has been introduced by Vidyasagar University from the 2017-18 academic session and our college follows the CBCS pattern from the same academic session. In the CBCS pattern, Internal Assessments (IA) are held twice per academic session for both Honours and General courses, and the evaluation of the answer scripts is done within a fixed timeline.
- The affiliating University provides guidelines for Internal Assessment and End-Semester Examination (ESE). A student needs to attend at least 75% of classes in order to appear at the ESE. 10 marks are allotted for Internal Assessments of Core Course and 5 marks for Skill Enhancement Course (SEC). 5 marks are awarded on the basis of class attendance conducted by the departmental teachers.
- The college has an Examination Committee which undertakes necessary measures to ensure objectivity and transparency in the examination and evaluation process. Exam. notifications with the necessary information like date, syllabus, venue, etc. are displayed on the college website, college Notice Board and circulated through the departmental WhatsApp groups. The guidelines for Internal Assessments are reiterated by the teachers from time to time during regular classes.
- The performance of the students in the Internal Assessments are discussed with the students and suggestions are also shared with them. In some subjects, marks are awarded on the basis of assignments, presentations, and projects.
- During the COVID-19 pandemic, the pattern of examination was shifted from offline to online mode. Internal Assessment was conducted through the University online examination portal. Students downloaded the question papers and answer booklets from the university examination portal and sent the scanned copy of their answer scripts to the respective departmental email ids

for evaluation. After the evaluation of the answer scripts, the teachers upload the marks on the university portal for the final publication of the results.

- Students are free to raise their grievances regarding the marks awarded to them with the faculty concerned. In rare cases, if the students' grievances are not resolved satisfactorily by the faculty members, they are free to approach their mentor or the Principal for redressal.
- For grievances related to the evaluation of End-Semester Examinations conducted by Vidyasagar University, students go for an official procedure of reviewing of that particular paper within a stipulated period, by bringing the matter in writing to the concerned center supervisor and the Controller of Examinations, Vidyasagar University through the Principal.
- The Academic Council, approved by the Government Body, monitors and regularizes the teaching-learning processes and examination procedures.

#### **Response:**

Spread over 11.4 acres of land with a built-up area of 9712.46 sq. mts., the college has an adequate infrastructure and physical facilities for effective teaching-learning, cultural, extra-curricular and sports activities.

- Old Building: Established in 1964, the two-storied building of the college has 13 classrooms and one Teachers' Common Staff Room at the ground floor. The classes of English, History, Philosophy, Economics, Sanskrit etc. are held in these classrooms. The classes of several science subjects such as Botany, Anthropology, Physics, Zoology, etc. are held in the classrooms situated at the first floor of the building. Silver Jubilee Hall, one big Hall constructed on the occasion of the twenty-fifth anniversary of the college, is situated on the first floor of this building. This Hall is used for multiple academic, cultural and administrative purposes.
- New Building: Completed in 2012, this four-storied new building, equipped with all the necessary infrastructure such as electricity, water supply, sewage systems, and internet connectivity, hosts the departments of Bengali, Geography, and Santali. Central Library of the college and the spacious and well-decorated Reading Room is situated at the first floor of this new building.
- Science Block: Department of Chemistry is situated at the ground floor of this two-storied Science Block. On the first floor of the building, the classes of departments of Physical Education and BPED are held. The Study Centre of NSOU (Netaji Subhas Open University) is also situated on the first floor of this Science Block
- Administrative Building: Built with the financial assistance of Paschimanchal Unnayan Parshad (PUP), a unit of Govt. of West Bengal, the Administrative Building of the college is a modern and sophisticated building which hosts the Principal's Chamber, Office, Seminar Hall, Yoga Centre, IQAC Room, NAAC Room, etc.

- The Central Library is following Dewey Decimal Classification (DDC) (19th ed.) & Anglo-American Cataloguing Rules (AACR) (2nd Rev. ed.). for technical processing.
- For smooth functioning of the Central Library, a Library Sub-Committee is functioning headed by the Principal as Chairperson assisted by Librarian as Convener and representatives of different departments as members.

# 6.1 Institutional Vision and Leadership

# 6.1.1

The institutional governance and leadership are in accordance with the vision and mission of the Institution and it is visible in various institutional practices such as NEP implementation, sustained institutional growth, decentralization, participation in the institutional governance and in their short term and long term Institutional Perspective Plan.

# **Response:**

The vision of Seva Bharati Mahavidyalaya is to transform the college "into a center of excellence in the arena of higher education and contribute to the inclusive development of the country by generating quality human resources." The college aims at the holistic development of the young learners and hopes to mould them into young citizens of the nation who are dependable, honest, committed and possess a sound value system. The college works tirelessly with the mission "to provide quality education to the students who basically belong to the economically disadvantaged section of the society."

The Governing Body (GB) is the highest administrative body that functions according to the Statutes, Rules and Ordinances of UGC. The Governing Body adopts policies and programs in the academic and administrative areas for the sustained growth of the institute. It works in coordination with the Principal and IQAC for proper functioning of the college and for achieving the goals set by the college. The Governing Body is constituted according to the West Bengal Act VII of 2017, with the Principal as the Secretary, Teachers' representatives (TR), Members nominated by Government of West Bengal (Government Nominees), Members nominated by affiliating University (University Nominees), non-teaching staff representative (NTR) and students' representative. The Teachers' representatives, non-teaching staff representative and students' representative are either selected or elected in a democratic process. The Governing Body is responsible for mobilizing funds for infrastructure upgradation, along with creating a conducive academic atmosphere in the campus.

The IQAC is responsible for ensuring quality in all academic activities of the college. The IQAC designs developmental plans and works in a systematic manner for the overall improvement of the academic as well as administrative performance of the college. For proper implementation of NEP from 2023-24 academic session, IQAC organized meeting with the Heads of the Departments for orientation of faculty members. Various departments of the college, under the supervision of IQAC, conducted several Value-Added Courses/ Certificate Course for enhancing the soft skills and professional skills of the students in keeping with the multidisciplinary and interdisciplinary needs of the NEP and for developing the research interests in diverse fields among the students of younger generation.

The college promotes decentralization and participative management within its administrative and academic practices by forming various Subcommittees and Cells with the faculty members, non-teaching staff and students. The members of Subcommittees/ Cells meet on a regular basis to discuss, participate in collaborative decision-making and organize various academic, administrative, and cultural activities as per the decisions taken in the meetings of the Subcommittees/ Cells. The departmental academic activities and programmes are coordinated by the Heads of the Departments. The Principal being the Head of the Institution plays a crucial role in monitoring the administrative and academic activities of the

college and coordinating with the Convenors of different Subcommittees/ Cells.

# 6.2 Strategy Development and Deployment

#### **Response:**

Being an affiliated college, Seva Bharati Mahavidyalaya follows the rules and regulations framed by the affiliating university, Vidyasagar University. At the same time being a grant-in-aid HEI, the college follows the rules and regulations of UGC and the Higher Education Department, Government of West Bengal. The Governing Body, constituted according to the West Bengal Act VII of 2017, is comprising of the Principal as the Secretary, Teachers' representatives (TR), Members nominated by Government of West Bengal (Government Nominees), Members nominated by affiliating University (University Nominees), non-teaching staff representative (NTR) and students' representative. The Governing Body being the highest administrative body of the institution is responsible for effective management of the administration and creating a conducive atmosphere for smooth conduction of the leaching-learning activities in the campus. The Governing Body conducts regular meetings to discuss various issues regarding infrastructure development, finance mobilization, faculty recruitment, introduction of new courses and various other issues for quality improvement of the college.

The Principal being the Secretary of the Governing Body and the Head of the institution implements the policies adopted by the Governing Body with the help of the Teachers, Non-teaching Staff, and Heads of the Departments.

The IQAC plays an important role in quality improvement and sustenance by designing developmental plans and effectively implementing them in academic and administrative sectors of the college. On the basis of the feedback collected from the stakeholders, the IQAC prepares an Action Plan at the beginning of each academic session and adopts policies for successful realization of the Action Plan.

The Governing Body, with the help of the Teachers' Council, forms various Subcommittees and Cells for effective management of the academic and administrative activities of the college. Academic Council, under the guidance of IQAC, frames policies for academic excellence and monitors the curriculum delivery within the time frame of each academic session. The Admission Committee supervises the admission procedure of students as per the guidelines of the affiliating university and the State Government. The Examination Committee monitors examination-related issues and conducts Internal Examinations and End-Semester Examinations conducted by the affiliating university. The Library Committee takes initiatives for procuring new books and journals and subject-wise books as

requisitioned by the Heads of different departments. The Service Book Committee of the college takes measures for upgradation of leaves in the Service Book of the teachers. The Placement and Promotion Cell of the college monitors the promotion of the teachers under the supervision of IQAC and Governing Body. The extension activities and sports and cultural programmes of the college are monitored by the NSS and Cultural Committee of the college.

Teachers' Council, a statutory body comprising of all the substantive teachers of the college, plays a vital role in planning and executing various academic activities through regular meetings and works for the academic excellence of the college.

Being a grant-in-aid college, Seva Bharati Mahavidyalaya follows the service rules and procedures of appointment of Principal, teaching and non-teaching staff as framed by the Government of West Bengal and UGC.

The Principal then sends letter to the Higher Education Department and affiliated University asking for recommendation of the Government nominee and University nominee/ subject expert respectively. After Screening/ Selection, the applicant is promoted to the next stage as per the UGC pay scale.
- The college encourages the teachers to participate in Orientation Programme/ Faculty Induction Programme/ Refresher Course/ Short Term Course/ Workshop for CAS and Seminar/ Webinar/ Online Courses for professional development and enrichment of research skills.

#### Welfare Measures for Teaching and Non-Teaching Staff:

- Provision for "West Bengal Health Scheme for the Beneficiaries of Grant-in-aid Colleges and Universities 2017" for the teachers appointed on substantive basis.
- Provision for "West Bengal Swasthya Sathi Scheme" for non-teaching staff and State-Aided College Teachers.
- Provision for joining the Cooperative Society (Employee's Central Cooperative Society, Seva Bharati Mahavidyalaya under Vidyasagar Central Co-operative Bank) available in the college to avail financial assistance for both the teaching and non-teaching staff of the college.
- The college provides full salary/ a certain portion of the salary in advance for the newly appointed teachers until the approval of the post and regularization of the salary by the Government.

# 6.4 Financial Management and Resource Mobilization

# 6.4.1

# **Response:**

The Governing Body of Seva Bharati Mahavidyalaya, the Principal, the Finance Committee, and the Purchase Committee work in coordination for mobilization of funds and optimal utilization of resources.

#### **Strategies for Resource Mobilization:**

- Salary grants from the Government as per norms for teaching and non-teaching employees.
- Fees collected from the students.
- Interests from savings deposits.
- Major/ Minor research grants received by the faculty from ICSSR/ UGC.

# **Strategies for Optimal Utilization of Resources:**

The college has a well-defined mechanism for effective and optimal utilization of financial resources for the development of academic processes and infrastructure. Resources are primarily utilized for:

- Staff salary
- Development of physical infrastructure
- Repair and maintenance of academic and physical support facilities
- Organization of Seminars/ workshops by the departments
- Sports and cultural activities
- Electricity charges
- Software and Internet charges
- Development of ICT infrastructure

The accounts of the college are regularly audited through Internal Audit and External Audit.

#### **Internal Audit:**

- The regular income and expenditure of the college is supervised by the Bursar, Accountant, and administrative staff.
- The bills of expenditure are finally placed before the Principal and the Finance Committee by the Accountant for final scrutiny.
- The Bursar, Finance Committee and the Principal are responsible for conducting the internal audit. The internal audit is conducted for continuous documentation of financial transactions of day-to-day expenditure.
- The college appointed a Kolkata-based private Internal Auditor (Amiya and Associates, Chartered Accountants) for preparation of audit report for the last five fiscal years (from 2018-19 to 2022-23).

#### **External Audit:**

- For external audits, the auditor is appointed by the Department of Higher Education, Government of West Bengal. The external audit has been conducted for the year 2017-18. Though the internal audits have been conducted for the last 5 fiscal years, the external audits for these remaining years are pending as the Government is yet to recommend the name of the Statutory Auditor.
- The Government-appointed external auditor conducts external audit at the end of each fiscal year, and the audited statements of income and expenditure and balance sheets are certified after proper verification of the documents. The audit report is submitted by the college to the Department of Higher Education, Government of West Bengal.

#### **Response:**

Internal Quality Assurance Cell (IQAC) of Seva Bharati Mahavidyalaya function in a deliberate, planned and systematic manner for achieving academic excellence of the college. It had significantly contributed to institutionalizing the quality assurance strategies and processes. As an advisory body, the IQAC monitors activities in the academic and administrative spheres along with adopting measures for quality improvement of teachers through research activities and career advancement. The following are the key contributions of IQAC in quality assurance and enhancement during the assessment period:

- Developing a feedback system from stakeholders for evaluation of teaching-learning processes and academic infrastructure of the college.
- Successful conduct of online teaching-learning during the pandemic.
- Successful organization of several national and international webinars and online lecture series by the various departments of the college.
- Empowering the faculty members through motivation to participate in faculty development programs (FDPs), OPs, RCs, etc.
- Registration of the Alumni Association of Seva Bharati Mahavidyalaya.
- Successful completion of more than 20 Value-Added Courses/ Certificate Courses for developing the soft skills and enhancing the employment opportunities of the students.
- Signing of MoUs with different governmental and non-governmental organizations/ institutes for strengthening academic collaborations and enhancing the scope for research activities by the faculty members.
- Conduct of academic, administrative, environment and gender audit.
- Encouraging faculty members to undertake Major and Minor Research Projects and also pursue PhD works. One faculty member has been awarded with the Major Research Project by the ICSSR.
- Encouraging faculty members to publish research papers in peer-reviewed journals and UGC Care-listed journals.
- Encouraging faculty members to publish Chapters in books published by the reputed publishing houses at national and international level.

The IQAC monitors and reviews the teaching-learning process regularly for assuring the quality of the institution. The IQAC makes periodical review of the teaching-learning process in the following ways:

- Students' feedback on academics, infrastructure, administration, and environment are collected and feedback report is analyzed for the improvement under the supervision of IQAC. The college introduced several Value-Added Course/ Certificate Courses on the basis of feedback collected from the students.
- Students' performance is evaluated through continuous internal assessment and remedial classes are arranged for the weak students.
- Teachers are asked to strictly follow the Lesson Plans and to finish the assignments within stipulated time.
- To review the teaching-learning process, structures and methodologies of operations and learning

outcomes at periodic intervals, the IQAC conducts Academic Audit, Administrative Audit, Green Audit, Energy Audit, Gender Audit, etc.

• The IQAC makes a review of the admission data and result-related data and places before the Principal for necessary action.

#### **Response:**

Seva Bharati Mahavidyalaya is sincerely committed to ensure equal opportunities for all genders in terms of their activities in the college and to promote gender equity. With the obvious intention of identifying weakness regarding gender balance within the college, the IQAC, in association with Internal Complaints Committee (ICC) and Women Cell of the college, conducted the Gender Audit. The college had adopted the following policies to promote gender equity and gender empowerment:

- The college does not practice any form of discrimination on the basis of gender. The college has a well-defined gender policy that is displayed on the college website.
- The college offers equal opportunities for voicing demands on academic and non-academic issues for all stakeholders. Special attention and support are given to the first-generation girl students from rural, social and economic backwardness.
- The Women Cell of the college organizes International Women's Day to celebrate the contributions of the women to the society. One of the primary objectives is to make the students aware about the gender issues and sensitize them about the multiple forms of gender discrimination, sexual harassment and gender empowerment.
- The college has Grievance Redressal Cell and Anti-Ragging Cell the member of which are proactive to address the issues of gender disparities and gender violence.
- The college takes proper initiatives for successful implementation of "Kanyashree Prakalpa", a scholarship scheme of the Government of West Bengal for the female students. A good number of female students are awarded the Scholarship in each academic session.
- The college offers several programs in which the issue of gender has been made an integral part of the curriculum.
- The college had adopted several safety measures for ensuring a safe environment within the campus. CCTVs are installed in different parts of the institution for surveillance. Identity Cards are issued for students and teachers to restrict the entry of trespassers.
- The college has Girls' Common Room dedicated for female students which is equipped with a sanitary napkin vending machine.
- The college offers sports and gym facilities for all students irrespective of their gender.
- Participation of female students in co-curricular and extra-curricular activities is encouraged through NSS and NCC units of the college.

Seva Bharati Mahavidyalaya adopts several measures to create an inclusive environment in the campus and to enhance the understanding of cultural, religious, linguistic, communal and socioeconomic diversities with the obvious objective of making the students aware of their constitutional rights, duties and responsibilities. The college takes the following initiatives to provide an inclusive environment:

#### **Cultural and Regional:**

- Different cultural and regional festivals like Basanta Utsav, Saraswati Puja, Raksha Bandhan, etc. are celebrated in the college every year.
- The birth anniversary of Rabindranath Tagore, Pandit Ishwar Chandra Vidyasagar are also celebrated every year.

- The curriculum prescribed by the affiliating university permits the students to choose languages like Bengali, Santali, Sanskrit, Hindi, English, etc.
- The college celebrates *Santali Bhasa Vijoy Dibos* on 22nd December every year with much fervour and enthusiasm.
- International Mother Language Day is observed on 21st February to instill the importance of mother tongue among the students.
- The Department of Sanskrit offered Certificate Course on "Communication Skills in Sanskrit" to

improve the communication skills in Sanskrit among the students.

• The Department of English offered Certificate Course on "Communicative English" to help the students improve their communication skills in English.

#### **Communal and Socio-economic:**

- The college take sincere measures to create an inclusive atmosphere in the classrooms in which the students learn to appreciate the diversity and plurality, and get sensitized about communal harmony and cultural pluralism.

# Title: USE OF ACADEMIC ERP SOFTWARE FOR MANAGEMENT OF ADMISSION AND ADMINISTRATION

#### **Objectives of the Practice:**

- To provide a simpler, effective, efficient, secured, cost-effective system of governance for the maximum benefit of all stakeholders.
- To comply with the admission guidelines of Higher Education Department, Government of West Bengal and the affiliating university, Vidyasagar University.
- To make the admission process and administrative works transparent, error-free, time-saving, and user-friendly.
- To centralize the data for effective management and utilization by the administration.
- To cope up with the changing scenario in academic processes and administrative systems in the post-COVID-19 pandemic situation.

#### The Context:

Seva Bharati Mahavidyalaya is a multidisciplinary college with the B.A., B.Sc., B.Com. (Hons. & General) & B.P.Ed. Courses and it offers degrees in 18 disciplines. More than 1500 students are enrolled across all the streams in each academic session. Apart from this, the college has more than 80 faculties, non-teaching staffs and casual workers. Physical maintaining of the academic, official and financial documents of this huge number of students and faculties is practically impossible. Moreover, it is not error-free. Preservation of such a huge amount of physical data is not feasible. Installation of an ERP Software can help the college to run smoothly, and can be beneficial for both the administration and for the stakeholders.

#### **The Practice:**

The college implemented the academic ERP software in admission process through the following ways:

- Conduct of online form fill-up of the applicants for admission
- Preparation of subject-wise merit list
- Online payment of admission fees
- Final admission through the online admission portal
- Generation of payment receipt of admission fees
- Preparation of Identity Card and Library Card of the admitted students
- Preparation of student data for university registration

The following administrative works were performed through ERP software:

- Management of finance and accounts
- Secured management of data regarding publication of research articles in journals and book chapters by the faculty members
- Maintenance of service documents of the teaching and non-teaching staff the college
- Management of student data related to admission, fees payment, progression, etc.
- Library automation through the Integrated Library Management System (ILMS)
- Preparation of the profile of the college staff and utilization of the information for administrative purposes

#### **Evidence of Success:**

The total admission process of a student takes 10-20 minutes for each student. Online payment of admission fees takes 5 minutes to complete. Payment related issues are also resolved in a smooth and hassle-free manner. Administration can effectively manage and utilize data for multiple academic and administrative purposes.

#### **Problems Encountered and Resources Required:**

The students coming from the rural tribal belt of the neighboring villages of the college have encountered problems in during online admission due to poor network connectivity, lack of smartphone and computer facility. To overcome the problem, the college creates a number of Helplines and opens Helpdesks for assistance during admission.

Cloud-based ERP software was the key resource required to resolve the issue.

# Title: ONLINE LECTURE SERIES ON "SUSTHA DEHE SUSTHA MON/ EI NIYEI ALAPAN" (A FRIENDLY DIALOGUE ON THE TOPIC OF "A HEALTHY BODY FOR A HEALTHY MIND")

#### **Objectives:**

- To create a platform for exchange of knowledge, ideas, research findings, etc. on the subject of Physical Education and Sports.
- To make the students familiar with multiple emerging issues related to physical fitness, sports science, mental health, and various other related topics.
- To foster new links and collaborations with academic and sports institutes of national and international repute.
- To establish professional connections for the future benefits of the students.
- To make the students aware about the cultural traditions of health and physical well-being of the country.

#### The Context:

With the ever-evolving landscape of higher education, the Physical Education Department of the college has felt the urgency of making the students familiar with the emerging issues in the subject. The program is designed to provide a unique platform for both students and teaching faculty of the college with renowned scholars, sports persons and sports administrators from various colleges, universities, sports institutes at national and international levels. The program is also in keeping with the policy of National Education Policy (NEP2020) and the institution's vision of transforming it into an academic institute of excellence.

#### The Practice:

"Sustha Dehe Sustha Mon/ Ei Niyei **Alapan**" (A Friendly Dialogue on the Topic of "A Healthy Body for a Healthy Mind") is an online lecture series organized by the Physical Education Department of the college in association with Physical Education Foundation of India (PEFI), National Sports Promotion Organization, recognized by the Ministry of Youth Affairs and Sports, Govt. of India. Renowned Professors, Vice Chancellors of various universities, Sports Persons and sports administrators at national and international levels are invited to deliver a lecture on diverse issues.

#### **Evidence of Success:**

- The success of the online lecture series is evident in the increased exposure to global perspectives on the subject and culture of sports, and the positive reputation and recognition from several institutes.
- The program had facilitated the establishment of Memorandums of Understanding (MoUs) between the college and several other colleges, institutes, and sports organizations at national and international levels.
- The students of the Physical Education Department of the college had been exposed to different ideas, sports culture, methodologies, modern and emerging fields of research in their subject.
- The online lecture series had helped the rural students to use the digital devices and to access the virtual platforms with smartness and confidence.

#### **Problems Encountered and Resources Required:**

Poor network connectivity had sometimes interrupted the sessions. Recording of the lectures for the future benefit of the students had also been a major concern at the initial stages of the lecture series.

Computers with a good webcam, microphone and strong network connectivity had been used for smooth streaming of the online lectures and interactions with resource persons. A separate YouTube channel had been created to preserve the lectures for the easy access of the students for their future benefit.

#### UPLIFTMENT OF THE MARGINALIZED SECTIONS OF THE SOCIETY, PARTICULARLY THE SANTAL COMMUNITY, THROUGH VARIOUS POLICIES, SCHEMES, AND PRACTICES

Seva Bharati Mahavidyalaya is located in a rural, backward, and highly drought-prone area in the newlyformed Jhargram district of West Bengal. The soil of the area is lateritic and the land undulated, and mostly barren. Situated at the close vicinity of Kalabati Jungle, the college is surrounded by the underdeveloped villages which are predominantly inhabited by the poor people belonging to the Scheduled Tribes, Scheduled Castes, and other backward communities. Since its establishment in 1964 by Professor Pabitra Kumar Sen, the avowed purpose of the college has been to cater to the need of higher education of the people of ST, SC-dominated, underdeveloped and socially underprivileged, rural area of Jhargram Sub-Division of erstwhile Midnapore district. In consonance with its vision and mission, the college had contributed to the inclusive development of the country by generating quality human resources through providing higher education to the students who basically belong to the economically disadvantaged section of the society. Over the last six decades, the college had played a significant role in changing the socioeconomic conditions of the people of adjoining area through offering higher education.

Since the college is located in a tribal belt, the focus has always been on empowering the tribal people through quality higher education and outreach programs. With an objective to work for the development of the tribal people of the surrounding area, the college introduced UG Honours and General courses in Santali language. The curriculum of the programs is designed to enrich the students with the knowledge of tribal history, culture, heritage and linguistic and literary tradition of the indigenous people.

The college organizes *Bhasa Vijoy Dibos* for generating a sense of pride and respect for the rich linguistic traditions and promoting the culture of the Santal people. The college has SC/ST Cell, OBC Cell, Minority Cell to help the students belonging to the socioeconomically backward classes of the society. The college provides Hostel facilities for both the boys and girls students. The college has a separate Hostel for SC and ST male students. Various scholarships like Swami Vivekananda Merit-cum-Means scholarship, OASIS, "Kanyashree Prakalpa" are offered for the social and economically disadvantaged students. The NSS Units of the college organize several awareness programs for the benefit of the people of the neighboring community of the college. The students of the college participate in sports and games or cultural programmes organized by the departments of the college.

In addition to conventional teaching-learning, the college adopts several initiatives for the skill development of the students. During the assessment period, the college conducted various Certificate Courses/ Value-Added Courses for enhancing the communicative skills, research skills, life skills and soft skills of the students, and to make them competent for the modern job market of the 21st century. Seva Bharati Mahavidyalaya since its establishment had been focusing on the holistic development of the students by offering not only the conventional mode of education but also developing their skills, and most importantly, imparting value education for becoming the compassionate, responsible and lawabiding citizen of the nation.
