## PARTIES

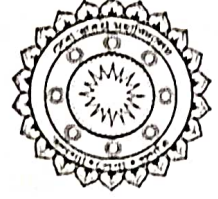

This Memorandum of Understanding (hereinafter called as the MoU) is entered on this day 5th April, 2022 by and between Vivekananda Mission Mahavidyalaya located in Chaitanyapur, Haldia, Purba Medinipur, Pin 721645, West Bengal, THE FIRST PARTY represented herein by its Principal (hereinafter called The First Party) of the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors - in - office, administrators and assigns.

THE SECOND PARTY (hereinafter called the Second Party), represented by the Principal of Seva Bharati Mahavidyalaya located in Vill. & P.O.-Kapgari: Dist.-Jhargram (W.B.): Pin.-721505, unless excluded by or repugnant to the subject of context shall include its successors - in - office, administrators or assigns First and Second Party are hereinafter jointly referred to as PARTIES and individually as PARTY.

### WHEREAS:

First party is a higher education institution named:

**Vivekananda Mission Mahavidyalaya, Chaitanyapur, Haldia, Purba Medinipur, Pin 721645, West Bengal**

Second Party is also a higher education institution named:

**Seva Bharati Mahavidyalaya, Vill. & P.O.-Kapgari: Dist.-Jhargram (W.B.): Pin.-721505**

First Party and Second Party believe that collaboration and cooperation between themselves will promote effective use of each of their resources and provide each one of them enhanced opportunity.

Both parties, legal entities in themselves desire to sign a MoU for advancing their mutual interest.

Now therefore, in consideration of the mutual promises set forth in this MoU, the parties hereto agree as follows:

### CLAUSE 1: PURPOSE & SCOPE:

The purpose of this agreement is purely academic. Both the Parties are intending to specifically undertake:

- ✓ Student enrichment programmes targeted to college students and with an aim to make their development holistic.
- ✓ Customise course curriculums and training as per the requirements of the Industry.
- ✓ Carrying out different R & D activities.
- ✓ Carrying out different awareness programmes, seminars and symposiums, workshops, specialized trainings.
- ✓ Exchange of resource persons.
- ✓ Exchange of Students.
- ✓ Implementation of different CSR and/or socio-economic and environmental projects.
- ✓ Exchange of ideas and data that are required for conducting any research projects.
- ✓ Target towards collaborative and joint works on setting up an enabling environment to spread Education and Skill development and R & D know how, expertise, best practices in the areas of R & D, Higher education, Skills Training, Train the Trainer programmes, Assessment, training of Assessors, conduct Skill Gap analysis, provide specific knowhow on skills training and technology, prior learning recognition, create assessment and certification programmes.

### CLAUSE 2: MODE OF OPERATION:

Both parties will provide necessary support for effective implementation of the MoU within the institutional rules, regulations and procedures.

This MoU shall be effective from the date it is signed by both the parties.

### CLAUSE 3: FINANCIAL ARRANGEMENTS:

No financial commitment is required /involved to execute the terms and conditions of the MoU. In case of any financial assistance received as extramural grant **Vivekananda Mission Mahavidyalaya** and/or **Seva Bharati Mahavidyalaya**, then that will be duly audited and acknowledged.

### CLAUSE 4: PERIOD AND APPLICABILITY:

Unless terminated earlier as per the provision herein contained, this agreement shall be valid for an initial period of 3 (Three) years from the date of signing of this MOU. Subsequently, this agreement may be renewed for such further term or terms as may be mutually agreed upon.

### CLAUSE 5: TERMS AND CONDITIONS:

It is mutually understood and agreed by and between the Institutes viz. **Vivekananda Mission Mahavidyalaya** and **Seva Bharati Mahavidyalaya**, that:

1. **Vivekananda Mission Mahavidyalaya** and **Seva Bharati Mahavidyalaya** may mutually use and share educational facilities and may jointly guide students at various levels of academia.

3. The MoU may be terminated by either party after giving a notice of **six months (180 days)** provided that this clause will be operative only if either party violates the terms of MoU or if the parties feel that no useful purpose would be served by further continuing it either due to change in circumstances or change in constituting parties.

Any divergence or differences derived from the interpretation or application of the MoU shall be resolved by arbitration between the Parties.

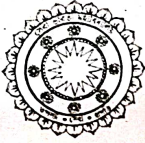

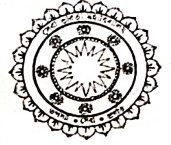


